Maahanmuuton tilannekatsaus 1/2017

Sisäministeriö, helmikuu 2017, 30 s. (Sisäministeriön julkaisu 4/2017)

Maahanmuuttokeskustelua viime vuodet hallinnut turvapaikanhakijatilanne on edelleen ajankohtainen kysymys Suomessa ja Euroopassa. Vaikka tulijoiden määrä on muun muassa Euroopan unionin sisärajatarkastusten myötä vähentynyt, ei tilanteen voida sanoa laantuneen. Kriisin taustalla vaikuttavat syyt, kuten sodat ja konfliktit eivät ole poistuneet. Turvapaikanhakijamäärien mahdolliseen kasvuun vaikuttavat myös EU:ssa tehdyt ratkaisut, kuten EU:n ja Turkin välisen sopimuksen pitävyys.

"Except God, We Have No One": Lack of Durable Solutions for Non-Syrian Refugees in Turkey

Refugees International (RI), Feb. 2017, 20 pp.

Based on field research conducted in a number of Turkish cities in December 2016, the report describes the difficulties non-Syrian refugees face in supporting themselves financially, finding adequate housing options as well as restrictions on their movement under Turkey's "satellite city" asylum system. Given that government actors and humanitarian organizations focus primarily on Syrian refugees, refugees and asylum-seekers of other nationalities experience discrimination and neglect and feel invisible in Turkish society and to the wider international community. Many face particular vulnerabilities, including LGBT people, single women and single parents, survivors of sexual or gender-based violence, religious minorities, and refugees from African countries.

Amnesty International, Feb. 2017, 48 pp.

At Saydnaya Military Prison, the Syrian authorities have quietly and methodically organized the killing of thousands of people in their custody. Amnesty International's research shows that the murder, torture, enforced disappearance and extermination carried out at Saydnaya since 2011 have been perpetrated as part of an attack against the civilian population that has been widespread, as well as systematic, and carried out in furtherance of state policy.

Pakistan Coercion, UN Complicity: The Mass Forced Return of Afghan Refugees

HRW, Feb. 2017, 86 pp.

The report documents Pakistan's abuses and the role of the United Nations High Commissioner for Refugees (UNHCR) in promoting the exodus. Through enhancing its "voluntary repatriation" program and failing to publicly call for an end to coercive practices, the UN agency has become complicit in Pakistan's mass refugee abuse. The UN and international donors should press Pakistan to end the abuses, protect the remaining 1.1 million Afghan refugees in Pakistan, and allow refugees among the other estimated 750,000 unregistered Afghans there to seek protection, Human Rights Watch said.

"I Had a Dream to Finish School": Barriers to Secondary Education in Tanzania

HRW, Feb. 2017, 131 pp.

The report examines obstacles, including some rooted in outmoded government policies, that prevent more than 1.5 million adolescents from attending secondary school and cause many students to drop out because of poor quality education. The problems include a lack of secondary schools in rural areas, an exam that limits access to secondary school, and a discriminatory government policy to expel pregnant or married girls.

"When Will I Get to Go Home?": Abuses and Discrimination against Children in Institutions and Lack of Access to Quality Inclusive Education in Armenia

HRW, Feb. 2017, 125 pp.

The report documents how thousands of children in Armenia live in orphanages, residential special schools for children with disabilities, and other institutions. They often live there for years, separated from their families. More than 90 percent of children in residential institutions in Armenia have at least one living parent. Human Rights Watch also found that the Armenian government is not doing enough to ensure quality, inclusive education for all children. Inclusive education involves children with disabilities studying in their community schools with reasonable support for academic and other achievement.

Hungarian Helsinki Committee, 2017, 24 pp.

Five human rights NGOs show that access to protection is increasingly limited in Bulgaria, the Czech Republic, Hungary, Poland and Slovenia. The NGOs urge European governments to find the right balance between protecting borders and providing access to protection to those in need of it.

A house divided: Political relations and coalition-building between Iraq's Shi'a

Clingendael Institute, Feb. 2017, 76 pp.

This online report analyses relation- and coalition-building between Iraq's main Shi'a political groups from 1991 to 2016. It focuses on the Islamic Da'wa Party, the Sadrist Trend, the Islamic Supreme Council of Iraq (ISCI) and Iraq's various irregular forces. It is visualised in the form of short timeline.

Turning the tide: The politics of irregular migration in the Sahel and Libya

Clingendael Institute, Feb. 2017, 80 pp.

This report analyses the relationship between irregular migration and conflict and stability in Mali, Niger and Libya. Studying the human smuggling networks that operate within and across these three countries provides insights into the transnational dynamics of irregular migration as well as these networks' interaction with local, national and regional political and economic dynamics. The report's main finding is that current EU policies are misaligned with the reality of trans-Saharan migration as they do not take into account the diversity of intra-African migration. In addition, human smuggling networks form part of larger political economies and cannot be ad-



dressed effectively without taking into account the extent to which state authorities are involved in and/or capable of controlling irregular migration.

Resettlement is receiving greater prominence not only in light of US President Donald Trump's recent actions but in the context of the recent surge in numbers of refugees. In the 33 feature theme articles in this latest FMR, authors from around the world look at some of the modalities and challenges of resettlement in order to shed light on debates such as how – and how well – resettlement is managed, whether it is a good use of the funds and energy it uses, and whether it is a good solution for refugees.

This FMR also contains a mini-feature (with four articles) on Post-deportation risks and monitoring plus four articles on other forced migration topics: climate displacement in Bangladesh, asylum seekers' consumption patterns, refugee and migrant children in Europe, and statelessness in Switzerland.
