① In shared accommodation, your daily housing costs are shared between two or more people. Daily housing costs include the costs of food, washing and cleaning or other similar costs. Living in the same apartment, for example as common-law spouses or as a married couple, is considered shared accommodation. Living with a nuclear family, such as siblings and parents, is also considered shared accommodation. Living with a close friend can also be considered shared accommodation, if the friends share the daily costs of housing.

① If you live alone, you are independently in charge of your daily housing costs, such as the costs of food, washing and cleaning. If you live in your own apartment or have a lease or a sublease, you are considered a single-person household. If you share your apartment with one or more people but your costs are separate and each person is independently in charge of their daily expenses, you are also considered a single-person household.
