

## Application for long-term visa (D visa)

① **Use this form, if you are applying for a long-term visa (D visa) to Finland. A long term-visa must be applied for abroad, before travelling to Finland. The applicant must visit a Finnish mission (embassy or consulate) to prove his or her identity.**

① Attach your passport photo and a valid travel document to the application.

2. Fill in the form carefully. Remember to sign the form. Incomplete information will delay the processing of your application and may lead to your application being rejected.

3. Submit your application at a Finnish mission (embassy or consulate) abroad.
4. The application is subject to a fee. Pay the processing fee when you submit the application. We will not start processing your application before you have paid the processing fee.

① **You can be granted a D visa to enter Finland if you wish to receive your residence permit card in Finland and are applying for or have been granted one of the following residence permits:**

- **Residence permit for a specialist**
- **EU Blue Card**
- **Residence permit for a start-up entrepreneur**
- **Residence permit for specialists on the basis of intra-corporate transfer (ICT residence permit)**
- **Residence permit for a family member of a person issued with or applying for one of the above-mentioned permits.**
