You will also be issued a <i>personal identity code</i> if you do not yet have one.</p> <p>The <b>Population Information System</b> is Finland's electronic population register. Its contents are available to all Finnish authorities. Some of the data can also be disclosed to private persons or entities. The register is kept by the Digital and Population Data Services Agency. The personal information in the register is stored permanently.</p> <p>A <b>personal identity code</b> is a means of identification used in Finland. No two persons can have the same personal identity code. The code consists of 11 characters and is based on your date of birth and your gender (example: 131052-308T). Being issued a personal identity code gives you no rights or obligations in Finland. You will usually need it when you contact public authorities, because it gives them access to your information in the Population Information System. Also, for instance employers, banks or phone operators may need to know your personal identity code.</p> <p>At this stage, the following personal data will be recorded in the Population Information System: your name, date of birth, gender, citizenship, native language, address and occupation. More information about the processing of personal data recorded in the Population Information System can be found in the privacy statement available at <a href="https://dvv.fi/en/pis-privacy-statement">dvv.fi/en/pis-privacy-statement</a>. You may also request a paper copy from the Finnish Immigration Service or from the Finnish mission (embassy or consulate) to which you return this application.</p>
