REQUEST TO DETERMINE CITIZENSHIP STATUS

This form is for you if you wish to request determination of your citizenship status, if the information on you in the Population Information System is incorrect, or if you need a decision issued by an authority concerning what the Finnish authorities consider your citizenship to be.

This form is also for you if you wish to determine the citizenship of your child. In the latter case, enter data on the child in section A 1 and data on yourself in section A 3.

Carefully fill in and sign the request form. Incomplete information will delay the processing of the request.

A fee is charged for the decision on determining citizenship. The fee is EUR 100 and must be paid in advance into the Finnish Immigration Service's account Danske Bank FI59 8129 9710 0117 35 or Nordea FI86 1804 3000 0154 04. Note that you must cover the bank's fees for the transfer. Enter the name of the requester and the words "Request to determine citizenship" in the message field. The decision will be issued in Finnish or Swedish.

- My citizenship is given as Finnish in the Population Information System, but I also have citizenship of another country.
- My citizenship is given as Finnish in the Population Information System, but I am no longer / I have never been a Finnish citizen.
- I wish to find out whether I lost my Finnish citizenship on my 22nd birthday.
- I wish to find out whether I am / I have been a Finnish citizen
- I wish to find out what the Finnish authorities consider my citizenship to be.
- I wish to find out whether the Finnish authorities consider me to be a stateless person.

D. APPENDICES

All documents attached must be originals. If a certified copy has been attached instead of the original, the Finnish Immigration Service may request the original document to be submitted.

For any foreign documents attached, you must provide a translation into Finnish or Swedish by an authorized translator. If a document issued by a foreign authority has not been legalized or is not accompanied by a certificate issued by the foreign authority concerning the reliability of the document, the Finnish Immigration Service may request that the document be legalized or that such a certificate be attached to the document. Do not attach documents that have not been certified.

Enclose clarifications with the request and tick the boxes below as appropriate.

Obligatory appendices:

- Valid passport, or other identity document if you have no passport.
- Receipt showing that the processing fee has been paid.
- Birth certificate including parents. Your birth certificate is not needed if your information is entered in the Finnish Population Information System.
- Proof of citizenship of another country (e.g. copy of a valid passport issued by another country).
- Clarification of whether your parents were married to each other when you were born (e.g. marriage certificate, if this information is not entered in the Finnish Population Information System).
- Clarification of acknowledgement/confirmation of paternity, if this information is not entered in the Finnish Population Information System.
- Clarification of the citizenship of your parent(s) at the time of your birth (e.g. copy of naturalization document issued to your parent(s) or of document granting right of residence in another country if your parent(s) still have Finnish citizenship).

The information you have given on this form will be recorded in the electronic case management system (UMA) of the Finnish Immigration Service. The UMA system is used for processing, decision-making and monitoring of matters governed by the Aliens Act and the Nationality Act. All documents related to the processing of your matter will be filed in the UMA system. More detailed information of the processing on your personal data and your rights related to the processing will be given in the privacy statement of the UMA system.
