Obligatory clarification:

Valid passport, or other identity document if there is no passport (section 2)

Birth certificate indicating parents and place of birth, if the child is not registered in the Finnish Population Information System.

Other clarifications:

The information you have given on this form will be recorded in the electronic case management system (UMA) of the Finnish Immigration Service. The UMA system is used for processing, decision-making and monitoring of matters governed by the Aliens Act and the Nationality Act. All documents related to the processing of your matter will be filed in the UMA system. More detailed information of the processing on your personal data and your rights related to the processing will be given in the privacy statement of the UMA system.
