① When you apply for Finnish citizenship for yourself, you can simultaneously apply for Finnish citizenship for a child under 18 years of age if you have custody of the child. Fill in the form KAN_LIITELOMAKE for the child. A child under 18 years of age can be granted Finnish citizenship only together with you.

2. Fill in the form and any attachments carefully. Remember to sign the forms. Any missing information will delay the processing of the form and may lead to its rejection.

4. A fee is charged for processing a citizenship declaration. You need to pay the processing fee when you submit your declaration. Your declaration will not be processed before you have paid the processing fee.
