**i Use this form to apply for Finnish citizenship if you are a former Finnish citizen.** You can use this form to apply for Finnish citizenship for yourself and a minor child who is in your custody. If you are at the same time applying for citizenship for your child, also complete the form KAN\_LIITELOMAKE in addition to this form.

4. A fee is charged for processing a citizenship declaration. You need to pay the processing fee when you submit your declaration. Your declaration will not be processed before you have paid the processing fee.
