

Request for a certificate for seasonal work

① Use this form to request a certificate for seasonal work if you are a citizen of a visa-free country and are coming to Finland for seasonal work for a maximum of 90 days. The certificate will prove your right to do seasonal work in Finland.

① You cannot apply for a residence permit with this form. If your seasonal work lasts for more than 90 days, apply for a residence permit for seasonal work using the form OLE_TY6. You will find the form at migri.fi/en/seasonal-work-permit.

① A processing fee pursuant to the decree on fees will be charged for the request for a certificate. Pay the fee to the Finnish Immigration Service's bank account before sending the request.
