

## Response to possible denial of admittance or stay, deportation, or entry ban

ⓘ If you are denied the registration of the right of residence of an EU citizen or are not issued with a residence card in Finland for a family member of an EU citizen, or you have no other grounds for residing in Finland, you can be denied admittance to or stay in Finland or deported to your home country or country of permanent residence. If you receive a negative decision on your application, you will also be issued with a decision on deportation or denial of admittance or stay. Under the Aliens Act, you may also be imposed with a fixed-term entry ban to Finland or the entire Schengen area.
