



Notice of voluntary return to home country

① Use this form if you have refugee status or subsidiary protection status in Finland, wish to give up your international protection status, and intend to return voluntarily and permanently to your country of nationality or your earlier country of permanent residence.

1. Fill in the form carefully. Remember to sign the form.
2. Scan the form and send it by encrypted email (from the address securemail.migri.fi) to the address migri@migri.fi. The Securemail service will encrypt your message. Messages sent via the service will reach the Finnish Immigration Service reliably.
3. If you have a passport issued by your country of nationality, attach a copy of the passport to your message. If you do not have a passport issued by your country of nationality, attach a copy of the travel document issued by the Finnish Immigration Service to your message.
4. Complete own forms for each person who is returning. For a child who has turned 15, the form must be signed by the child and by the person who has custody of the child. If the form concerns a child under the age of 15, it must be signed by the person who has custody of the child. If two persons have custody of the child, both persons must sign the form.

Please note that if you return to your home country, the Finnish Immigration Service may

- end your refugee status or subsidiary protection status
- withdraw your residence permit
- withdraw your refugee travel document or alien's passport.

When the Finnish Immigration Service decides to withdraw your residence permit, you will receive a written decision. You can appeal against the decision to an administrative court. If you notify that you are giving up your international protection status, your protection status will be ended and you will receive a written decision on the matter. You cannot appeal against the decision to an administrative court.
