## APPLICATION FOR REVOKING A PROHIBITION OF ENTRY

This form is used for applying for revoking a prohibition of entry. A prohibition of entry may be revoked on the basis of a change in circumstances or for important personal reasons. A prohibition of entry is revoked only in exceptional cases.

A processing fee pursuant to the decree on fees will be charged for the application. The processing fee of 100 euros should be paid in advance to the Finnish Immigration Service's bank account FI50 5000 0121 5029 82. If you pay the fee abroad, please give the following information: Pohjola Bank Plc, BIC: OKOYFIHH and IBAN: FI50 5000 0121 5029 82. Write your name and the text "MTK PER" in the message field of the bank transfer. Attach a document on the payment to your application.
