MOBILITY NOTIFICATION FOR RESEARCHER

Use this form to submit a mobility notification, if you intend to move to Finland from another EU Member State in order to conduct scientific research and if you meet the following conditions:

- You have been granted a residence permit for research by an EU Member State and
- you meet the conditions for mobility and
- you will move to Finland for a maximum of two years and
- you will carry out part of the research activity in a research organisation.

You cannot apply for a residence permit with this form.

A processing fee pursuant to the decree on fees will be charged for your notification. The processing fee should be paid in advance to the Finnish Immigration Service's bank account FI50 5000 0121 5029 82. Write your name and the text "Liikkumisilmoitus TK1_EU" in the message field of the bank transfer. Attach a document on the payment to your notification.

- Colour copy of the page containing your personal data in your valid passport
- Copy of the residence permit granted to you by an EU Member State covering the whole period of your stay in Finland
- Hosting agreement signed by you and the research organisation in Finland containing the following information:
 - the title and purpose of the research activity or the research area;
 - an undertaking by the researcher and the research organisation to endeavour to complete the research activity;
 - the start and end date or the estimated duration of the research activity;
 - information on the legal relationship between the research organisation and the researcher;
 - information on the working conditions of the researcher, if the legal relationship between the research organisation and the researcher is an employment relationship
- Clarification of income (to prove that you have sufficient financial resources for your entire stay in Finland)
- Copy of the payment receipt (for the processing fee)
- Certificate of a second-cycle degree if you have been granted a residence permit for studies by some other EU Member State than Finland and you will carry out part of the research activity in Finland

The information you have given on this form will be recorded in the electronic case management system (UMA) of the Finnish Immigration Service. The UMA system is used for processing, decision-making and monitoring of matters governed by the Aliens Act and the Nationality Act. All documents related to the processing of your matter will be filed in the UMA system. More detailed information of the processing on your personal data and your rights related to the processing will be given in the privacy statement of the UMA system.
