



Mobility notification for researcher

① Use this form to submit a mobility notification, if you intend to come to Finland from another EU Member State in order to conduct scientific research.

You have the right to conduct scientific research in Finland, if

- you have been granted a residence permit for research by another EU Member State
- you meet the conditions for mobility
- you will move to Finland for a maximum of two years, and
- you will carry out part of the research activity in a research organisation.

You cannot apply for a residence permit with this form.

1. Please read the instructions on how to submit the notification, on processing fees and the required attachments at migri.fi/en/mobility-notification-for-researchers.

The attachments needed for the notification are listed in this form under 'Attachments'.

2. Fill in the form carefully. Remember to sign the form. Incomplete information will delay the processing of your notification and may lead to your mobility period being objected to.
3. The processing fee is 100 euros. Pay the processing fee into the bank account of the Finnish Immigration Service before sending the notification.
