- You are eligible for a P-EU residence permit if you have lived in Finland on a continuous residence permit (A permit) for an uninterrupted period of **five (5) years at the time when you submit this application**.

① If you are suspected of or have been found guilty of a criminal offence, you may be denied a permanent residence permit or P-EU residence permit.

① If the requirements for being granted a permanent residence permit are not met, you may be granted a new fixed-term extended permit on the basis of this application, provided that its requirements are met.
